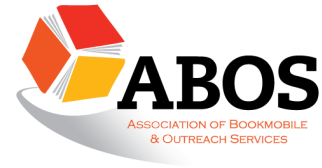

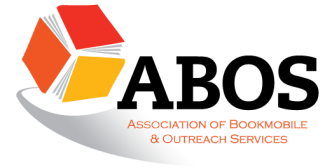
1. Introducing ourselves.
